## Call for Nominations for the Høst-Madsen Award 2021

Dear Colleague,

The Høst-Madsen Award is the highest Scientific Award of FIP. It is given every second year in the memory of Dr Høst-Madsen, who for many years was a very eminent President of FIP.

The Award is sponsored by the Danmarks Apotekerforening (Association of Danish Pharmacies).

A candidate for this Award is a distinguished research-active scientist who has made significant and outstanding contributions to the diverse field of pharmaceutical sciences. No prior affiliation with FIP is required.

The Høst-Madsen Medallist will be selected by the Høst-Madsen Award Committee. The recommendation of the Award Committee has to be approved by the Board of Pharmaceutical Sciences of FIP at its meeting in early 2021. The Awardee will receive the Høst-Madsen Medal at the FIP World Congress 2021 in Seville, Spain.

Any member of FIP (Member Organisations and Individual Members) may nominate any other Scientist in the Pharmaceutical Sciences for this Award.

I would like to ask you to nominate candidates and send your nominations **before** 1 December 2020 to Ms Paula Cohen, FIP Secretary, at paula@fip.org, who will then forward them to the Chair of the Høst-Madsen Award Committee.

Nominations must contain the following information:

- a. Curriculum Vitae of the proposed nominee (in English, detailing education, research and professional experience, honors/awards, publications/patents, and invited presentations)
- b. A concise statement summarizing the reasons why and how the nominee meets the selection criteria for this award (in English, not exceeding two A4/letter pages). A broad international view should be taken in proposing nominees.
- c. Name, address, e-mail and telephone number of the nominee
- d. Name, address, e-mail and telephone number of the individual/group making the nomination
- e. A recent, high quality colour photograph of the nominee (i.e., passport type)
